<b>WHAT IT DOES:</b>	Zipline ST improves water infiltration from the surface through the rootzone and promotes uniform hydration of the soil.
<b>WHERE &amp; WHEN TO USE:</b>	Zipline ST is safe to use on all turf types. Apply Zipline ST through conventional spray equipment in a minimum of 190 Ltrs. of water per hectare. For best results apply before next scheduled irrigation cycle.
